## Media Release

### **TBDSSAB Announces Capital Projects funded through Homelessness Prevention Program for 2024-25**

**December 17, 2024 –** The District of Thunder Bay Social Services Administration Board (TBDSSAB) is announcing capital investments in transitional housing funded through the province's Homelessness Prevention Program (HPP).

MPP Kevin Holland made the announcement on behalf of Minister Calandra today in Thunder Bay, with representatives present from TBDSSAB and funded organizations.

Today's announcement is part of the province's Homelessness Prevention Program (HPP), which provides funding to Ontario's 47 municipal service managers for affordable housing and support services for people experiencing or at risk of homelessness.

Three organizations have received capital funding toward six initiatives from TBDSSAB through HPP for the 2024-25 fiscal year. The combined total for all projects is \$8.3 million and 66 transitional housing units in the city of Thunder Bay.

Through HPP, TBDSSAB funds multiple homelessness prevention initiatives, including supportive housing, community outreach and support services, housing assistance and

emergency shelter solutions. Changes were made by the province to HPP funding parameters in 2022 to allow capital investments in transitional and supported housing.

For the 2024-25 fiscal year, TBDSSAB received \$16.5 million in HPP funding from the province and allocated over 50% to capital projects. Including today's announcement, TBDSSAB's HPP capital investments have supported the creation of 190 transitional housing spaces since 2022.

The tenants will receive support services to assist them in maintaining successful residency and reaching their personal recovery goals. Having a place to call their own will take them out of survival mode and enable them to focus on the next steps in their journey. In collaboration with our community partners, our future vision is to include a service hub on the premises."





## About TBDSSAB

The District of Thunder Bay Social Services Administration Board (TBDSSAB) supports people to improve their lives and become self-sufficient. We do this as the service system manager for vital, quality social services needed by individuals and families living in the District of Thunder Bay—including child care and early years, community housing, homelessness prevention programs—and through the delivery of Ontario Works.

### About HPP

The Homelessness Prevention Program (HPP) is a provincially funded program that supports Ontario's 47 municipal service managers to provide affordable housing and support services for people at risk of or experiencing homelessness. The objective of the program is to support service managers in preventing, addressing and reducing homelessness, including chronic homelessness.

Service managers receive funding from the province through the Homelessness Prevention Program to develop and deliver programs and supports to address homelessness that best meet local needs.

#### **Eligible Uses of HPP Funds**

Under HPP, service managers can create their own local programs under four broad service categories: Emergency Shelter Solutions, Supportive Housing, Community Outreach and Support Services, and Housing Assistance.<sup>1</sup>

Service Managers may also use HPP funding towards capital expenditures to support the creation and renewal of supportive housing and emergency shelters. Service managers are required to complete an annual investment plan outlining how they plan to use their HPP allocations each year for ministry approval.
